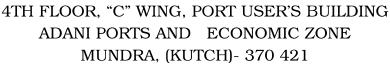

Subject: - Delay in filing APR at APSEZ

UAC observed that there are instance of delayed/non-submission of APRs by the units in terms of the prescribed timelines i.e. within a period of 180 days following the close of financial year in the form prescribed under the Special Economic Zone Rule 2006.

Thus, delay in submission beyond the prescribed time period is in violation of BLUT condition and also of Rule 22 of SEZ Rules, 2006. Therefore, UAC decided to impose penalty under FT (D&R) Act, 1992 read with Rule 54 of SEZ Rules, 2006.

The Committee decided that the APR filed beyond the stipulated time period shall be liable for penalty in the following manner:

- a. If APR is not submitted within a period of 180 days following the close of financial year in the form prescribed under the Special Economic Zone Rule 2006 of that year, then a Minimum Penalty of Rs-10,000/-for Delay up to 20 days shall be imposed.
- b. For delay beyond 20 days' in filing APR, a penalty of Rs. 500/-per day shall be levied on the unit till the date the unit submits their APR for the particular Financial Year.
- c. In cases where the delay in submission of APR is for more than one year, the UAC will decide the further course of action in terms of SEZ Act and rules.
